### ORDER:

As per the letters 2<sup>nd</sup> read above, the Government of India had conveyed their approval for continued implementation of the ICDS Scheme in the 12<sup>th</sup> Five Year Plan and implementation of restructured and strengthened ICDS Scheme in Mission Mode which inter-alia include repositioning the AWC as a “vibrant ECD centre” to become the first village outpost for health, nutrition and early learning (minimum of six hours of working), focus on under-3s, care and nutrition counseling particularly for mothers of under-3s, identification and management of severe and moderate underweight through community based interventions Sneha Shivirs, decentralized planning and management, flexible architecture- flexibility to States in implementation for innovations, strengthening governance – including PRIs, partnerships with civil society, introducing APIP and MoUs with State/UTs, etc,. Further considering the price escalation during the period after last revision and the demands from the various States/UTs, the cost norms for Supplementary Nutrition Programme (SNP), were revised by GOI as per details given below:

(i) Children(6-72 months)	Rs.4.00	Rs.6.00
(ii) Severely underweight children (6-72 months)	Rs.6.00	Rs.9.00
(iii) Pregnant women and Nursing mothers	Rs.5.00	Rs.7.00

2. The Government of India made applicable the revised cost norms for SNP for 3 Districts i.e. Guntur, Srikakulam, Karimnagar from 2012-13 and for another 8 districts i.e. East Godavari, Khammam, Ranga Reddy, Visakhapatnam, Adilabad, Ananthapur, Nizamabad & Vizianagaram from 2013-14 onwards.

3. In the letters 3<sup>rd</sup> read above, the Commissioner, WD&CW has stated that a State Committee was constituted under the Chairmanship of Managing Director, AP Foods with representatives from NIN, UNICEF, NGOs, Home Science College, Dept. of Women Development & Child Welfare Nutrition experts etc., to study various aspects of existing Food Models and the modifications to be made in view of the revised cost norms communicated by the GOI. After detailed discussions the State Committee has suggested to implement only one Food Model for one category of beneficiaries in all ICDS Projects throughout the State. The Committee pointed out that due to implementation of two types of Food Models i.e., Ready-to-Eat and Local Food Model in different Projects in the same district, there are continuous demands/representations from the beneficiaries as well as stake-holders to change the Food Model in their AWC/Project.

4. He has further stated that due to implementation of different Food Models for the same category in districts, monitoring has also become a major challenge. The Committee in view of the recommendation of GOI also strongly advised to provide Hot Cooked meal on the lines of Mid-day meal for 3-6 years Children and weaning food for 7 months - 3 years Children in all ICDS Projects. The Committee also suggested to consider adding 8 to 10 gms of Milk powder and increase sugar content in the present weaning food to improve acceptability, palatability and nutritive value for Children below 3 years.

5. In light of the above the Commissioner, WD&CW has proposed new Food Models with revised cost norms and requested the Govt. to accord permission to introduce the same as per the GOI revised norms.

6. After careful consideration of the matter, Govt., hereby accord permission to Commissioner, WD&CW to introduce new Food Models immediately (giving due time to MD, AP Foods for transition) as per the revised cost norms of GOI as appended to this order. The 12 Districts where revised cost norms of GOI under restructuring will be applicable from 2014-2015, will also follow the Food Models now prescribed for the 11 districts, from 2014-2015 onwards

7. The Commissioner, WD&CW is requested to issue instructions accordingly to all the field staff and Anganwadi Workers/Helpers to implement the said new Food Models at the Anganwadi Centres.

8. This order issues with the concurrence of Finance (Expr.WD&CW) Department vide their U.O.Note.No.3297/25/Exp.WD/2013, Dt:13/03/2013.
